Dear Parents, Carers and Children,

I would like to start by saying a huge thank you to each and every member of our school community for their help and support during another challenging half term. Unfortunately we have seen an increased number of positive COVID-19 cases within our community and this has impacted on many areas of school life but it has been wonderful to see how everyone had adapted and supported each other. I know that there have been lots of questions linked to PCR testing and I would like to thank everyone who has promptly sought a test for their child which has either identified someone who would possibly not have known they had COVID-19 or has confirmed that they can continue to come into school. Given the increasing number of cases throughout the county and country, I feel that these requests for testing are likely to continue. We will continue to keep parents/carers informed as positive cases are confirmed in classes so that PCR tests can be sought for close contacts and further positive cases can be identified to self-isolate so that we can help to stop the spread of the virus.

Well done to all the children who have been in school throughout the half term and also to those who have needed to self-isolate but have been able to engage with their remote learning when they have been well enough. You should all be really proud of all your hard work this half term. We wish everyone who has had COVID-19 a speedy recovery and look forward to seeing you back at school very soon.

<u>PARKING UPDATE - Traffic Regulation Order - Restricted Parking</u> - A traffic regulation order was approved some time ago for Nursery Road and Wimbotsham Road, and I can confirm that double yellow lines have been marked and parking restrictions will be in place in these areas from 0800 to 0930hrs and 1400 to 1600hrs Mon to Fri. Please do not park in these areas during these times as you are likely to be fined for doing so.

On a linked note, please can I remind parents and carers that they <u>SHOULD NOT</u> be driving into the school grounds at drop off and collection times unless they are a blue badge holder or by prior agreement with myself, another member of the Senior Leadership Team or the Office Team. Access at these times is restricted to staff, the school bus and taxi services only.

It has been fantastic to have some normality back at school this half term. We have seen the return of swimming lessons at the local swimming pool, children representing the school at sporting events and of course the return of the annual Norfolk Open Studio Art Exhibition. We look forward to continuing with events like these as and when our COVID-19 risk assessment allows. Unfortunately we have had to make the decision not to go ahead with face to face parent meetings in November so telephone appointments will be offered again. Please see the additional information later in this newsletter ref making an appointment to speak to your child's class teacher. We will be continuing with our 'Library Launch' when we return to school in November but unfortunately we have made the decision not to invite additional visitors into school at this point in time. Thank you to everyone who contacted me to offer their time to come in, we really hope that we can invite you in at another time as COVID allows.








Instagram is an image and video sharing app that allows users to share moments with the world. The app has a live streaming feature and additional add-ons, such as 'Boomerang', 'Hyperlapse' and 'Layout', which can be used to enhance their feed. Users can choose to add filters and make adjustments to their photos, such as brightness/ contrast. To make their content more 'searchable', users can include hashtags in their uploads to make them easier to find.

LIVE STREAMING TO STRANGERS

LIVE STREAMING TO STRANGERS

The live stream feature on Instagram allows users to connect with their friends and followers in real-time.
Illowers can comment on the video during the broadcast which can be turned off in the settings). If your child has a private account, only their approved followers can see heir story. It is important to note that they still may have ellowers that they do not know, which means they could be live streaming to strangers. A public account allows anybody to view their story. We suggest that your child goes through their followers list and blocks people they do not know. An additional risk with live streams is that rour child may do something that they regret. This could be captured by a viewer taking a screenshot and further shared around the internet.



DAMAGE TO CONFIDENCE, BODY IMAGE & MENTAL HEALTH

When influencers, celebrities or peers use filters on their photos or videos on instagram, it can set unrealistic expectations of their own appearance and create feelings of inadequacy and low self-esteem. Children may try to strive for a comparable number of likes on their own photo to an image or video that has been edited heavily.

NEW FOR MAY 2018

IN-APP PAYMENTS

Instagram is rolling out in-app payments for products and services directly through the app. It will operate under the same rules as Facebook Payments, which state if you are under the age of 18, you can only use Facebook Payments with the involvement of a parent or guardian.



PHOTO / VIDEO SHARING

Photing photos and videos is instagram's biggest selling point, so with sharing images comes risks. A photo which includes landmarks in the area, their school uniform, street name, house and even tagging in the location of the photo uploaded to instagram can expose the child's location making it easy to locate them. If their account is not set to private, anyone can access their account and see their limages.

HIJACKED HASHTAGS

Like Twitter, hashtags are also an extremely prominent tool in Instagram and with that, comes potential risks for your child. One person may use a soemingly innocent hashtag with one thing in mind and before you know it, hundreds of people could be using the same hashtag for something inappropriate or dangerous that your child certainly shouldn't be exposed to.

LOCATION TAGGING

Public locations can be added to a users photos/videos and also to their stories. While this may seem like a good idea at the time, it can expose your childs location; this is particularly more of a risk if it is on their story, as it is in

REMOVE PAYMENT **METHODS**

If you are happy for your child to have a card associated with their Instagram account, we suggest adding a PIN which needs to be entered before making a payment; this will also help prevent unauthorized purchases. This can be added in the payment settings tab.

RESTRICT MESSAGES

If your child's account is not private, anybody can message them and reply to their stories. If they do wish to keep their account public, we strongly recommend changing the message reply settings to restrict who can message them.

FILTER INAPROPRIATE COMMENTS

Instagram announced on 1st May that they now have an 'anti-bullying' filter on the app. The new filter hides comments containing attacks on a person's appearance or character, as well as threats to a person's well-being or health. The filter will also alert instagram to repeated problems so they can take action on the user if necessary. This is an automatic filter, but it can be turned off. Make sure this is turned on in the apps settings. is turned on in the apps settings.



TURN OFF SHARING

Even though this feature will not stop Even though this feature will not stop people from taking screenshots, it will stop others being able to directly share photos and videos from a story as a message to another user. This feature can be turned off in the settings. We also recommend turning off the feature which automatically shares photos and videos from a story to a Facebook account.

USE A PRIVATE ACCOUNT

By default, any image or video your child uploads to Instagram is visible to anyone. A private account means that you have to approve a request if somebody wants to follow you and only people you approve will see your posts and videos.
